  - B. The Client shall reimburse Photographer for any additional costs the photographer may incur for travel, parking, and other reasonable costs necessary to the performance of these services. Client must pay 50% on booking day and 50% must be paid of fee week before photographer begins photographing the day of the shoot. Preferred payment method is personal bank transfer.
  - **C.** Upon signature, the photographer reserves the time and date agreed upon, and will not make other reservations for that time and date. For this reason, the retainer is non-refundable, if event is cancelled for any reason, including, but not limited to acts of God, fire, extreme weather, sad news in family or break-up. Retainer is to be paid at time of parties signing this contract. Reservation retainer is applied towards the contracted photography package upon completion of this contract. If, for any reason, client changes event date, the retainer can be transferred to new event date if photographer has the date available; otherwise there is no refund for retainer paid.



- D. Proof photographs and Videography shall be shipped to the Client on personalize UBS stick and DVD by mail or in person on the next business day. The client will get all the work done by minimum 4 weeks after event day. There is no Album in paper to be provided all pictures will be providing in 10inch electronic tablet. Plus, complimentary item will be gift by Production.
- E. The Client shall assist and cooperate with the Photographer in obtaining the desired photographs, including but not limited to specifying persons and/or scenes to be photographed; taking time to pose for photographs at the Photographer's direction. The Photographer shall not be responsible for photographs not taken as a result of the Client's failure to provide reasonable assistance or cooperation.
- **F.** The client understands that the quantity of photographs taken at the event can vary greatly and that engagement photography by nature is an art, subject to the creativity of the photographer and her personal artistic style. The client understands that he/she has chosen the photographer because of her photographic style, and will grant the photographer the right to exercise her creativity in the interest of creating the best images possible. The client understands he/she may not demand a refund, or a redo due to differences in artistic preferences of the final images.
- **G.** In the event of unforeseen medical emergency in which photographer cannot photograph the event, photographer will make reasonable effort to arrange for a substitute professional photographer to conduct photography, or reschedule the photo shoot for another day.
- H. If the photographer cannot perform this agreement in whole or in part due to a fire or other casualty, acts of God or nature or terror, or other cause beyond the control of the parties or due to photographer's illness or injury, then the photographer will return all fees to the Client(s) (minus any costs already used i.e. plane tickets etc.) but shall have no further liability with respect to this agreement. In the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, stolen, or otherwise lost or damaged without fault on the part of the photographer, the photographer agrees to reschedule another session to do a reshoot.
- I. The Photographer retains copyright in the photographs, and hereby grants the client unlimited but non-exclusive rights to use or reproduce the photographs for which the client pays.
- J. On the days of event while performing no third parties or any other photographer or videographer to be present at event performing their work, without our (ak photograpger's) permissions. If so, we will stop our work on the spot until the third party is out of the event.



#### **Applicable Law**

This contract shall be governed by the laws of the County/Crown court and any applicable Federal law.
